CONTRACT

Registration for the 2021-2022 season requires a \$30.00 non refundable registration fee plus August tuition calculated at 1/2 the monthly rate. Registration constitutes an agreement to attend classes for the academic year.

We offer a 10% discount for siblings. Yearly Tuition Paid in Full receives a 10% discount.

Tuition is non- refundable and is due on the 1st of the month. A late charge of \$5.00 will be imposed on all accounts not paid by the 10th day or the month.

RECITAL COSTUME DEPOSITS in the amount of \$50.00 per class (non-refundable) are due in NOVEMBER.

RECITAL COSTUME BALANCES in the amount of \$25.00 per class are due in JANUARY.

A RECITAL TICKET FEE of \$75.00 per student is due in MARCH.

Withdrawals require a written 30-day notice. All current and past due fees and tuition are due at the time of notification of withdrawal.
